SUBJECT: Revised Holiday Closure

DATE: December 22, 2015

The University will observe the holiday closure from the end of business on Thursday, December 24, 2015 through Sunday, January 3, 2016. During that period Facilities Planning and Management will be taking steps to maximize energy cost savings. Where possible, buildings will be closed, locked down, and the temperatures reduced.

Enclosed is the revised final building operations plan with target temperature settings.
